- 2. <u>Minutes of the last meeting</u>: Approved and signed

3. Summer Show –

Notes received from Colin Carter reviewed, all clear. CC queried how person logging entries knew who was a non-member for entry fee – **CC** to send list of members to Colin Carter.

4. Finance:

£22712 in bank – CC queried whether worth continuing Paypal experiment, confirmed minimum payment applied because of fixed fee + %age per transaction. GC has submitted hall hire forms to school

5. <u>Membership</u>:

336 members. 171 plots (55 x whole, 82 xhalf, 34 x quarter) Latter popular with newer, young people, encourages them to continue. 1 vacant plot.

6. Trading:

LM – slow trading in July, £80-100 per weekend. May look elsewhere for onion/shallot/garlic. Potato competition winner info. To be emailed out in monthly note LMc

7. Allotments:

AM – 15 people on waiting list

Plots not cultivated to standard were checked on 27/06/22 and letters giving 28 days to improve sent out to 8 by SC.. Two now resolved, others to be re-inspected on Thursday 28/07/22 by **GC/AM/SC**.

8. <u>Allotment Roadway/Fencing/Footpath constrcution:</u>

SC – Fencing – had been to PC Hall & Grounds meeting on 21/06/22 and spelled out allotment situation, sent plan of top field requirement to PC as requested. Some correspondence from allotment holders resulting from last update sent on 27/06/22 led her to question whether should re-visit fencing decision as there are 56 new allotment holders since vote in 2021 and 1.8m high Heras fencing with restricted access has been in place for 6 months, no firm quotes for cost of lower field fencing. Number of Trustees consider security fencing needed against public and animal encroachment. Noted that new development has left allotments open to SINC and Tangier Lane. LM keen to pursue reduced fence option for lower field – this reduces costs but requires agreement of Parish Council and Cricket Club. If no full agreement then type of fencing to be reconsidered. **SC** to write to both parties.

9. Health & Safety:

WH and AM to conduct postponed review. Risk assessment document being reviewed by person with relevant experience.

10. Monthly Programme:

NJ – next meeting 28th September – she cannot be present so GC will need assistance. **SC**_to check on hire of Jubilee Hall for Social Evening.

11. Social Programme:

Agreed May/June 2022 for visit to Waterperry Garden.

12. Publicity / Social Media:

AL - Parish News late entry so September meeting missed. Twitter account – apparently we have one set up in 2018 – SC to mail AL email address of contact SC to notify LMc of items for monthly mail.

13. Community Orchard / Bautterfly Garden:

Orchard – plots all cultivated , wiring round trees to come down in autumn Butterfly Garden – no issues, SC still waiting for Parish Council to install new sleepers.

14. Matters arising not on the Agenda:

BWGC Recipe Book , A5 format. NJ - printing cost quote from Solent Design is:
pages (4 sides x cover +24 internal), colour, 50 =£110, 100+£165, 250 = £295 + design cost.
Could sell at £3 per copy. Ask members for recipes using fruit / vegetables. GC could design layout.
